

RESOLUTION NO. 3913

A RESOLUTION ESTABLISHING FEES FOR THE PARTICIPATION IN CITY-SPONSORED RECREATION PROGRAMS, COSPONSORED COMMERCIAL RECREATION PROGRAMS, AND AUTHORIZING RULES AND PROCEDURES FOR THE OPERATION OF THE SAME; RESCINDING RESOLUTION NUMBER 3843.

WHEREAS, the City of Overland Park sponsors organized community recreation programs available for public participation; and

WHEREAS, the City of Overland Park establishes and administers rules, regulations, and fees for participation in said recreation programs.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF OVERLAND PARK, KANSAS:

THAT, the following policies and fees be established:

- I. The City Manager, through the Recreation Services Director shall have the authority to establish rules, regulations, and procedures for participation in the City-sponsored recreation programs.
- II. The Director of Recreation Services shall administer said rules, regulations, and procedures as directed by the City Manager.
- III. The City Manager, through the Recreation Services Director shall have authority to establish fees of \$100 or less per person for special programs, such as clinics, tournaments, classes, and trips for the purpose of offsetting costs incurred to sponsor the special program.
- IV. Fees for participants of said community recreation programs shall be as follows:
 - A. Softball Program
 1. 20-Game Doubleheader League - \$650/team
 2. 10-Game Recreational Single Header League - \$330/team
 3. Special Request League - \$65/game
 4. Special Request League - \$30/hour
 - B. Volleyball Program
 1. League (eight weeks) - \$150/team
 2. Doubleheader League (eight weeks) - \$250/team
 3. Self-called League (no referees) – eight weeks - \$70/team
 4. Self-called Doubleheader League (no referees) – eight weeks - \$140/team
 5. Sand Volleyball League (eight weeks) - \$120/team

- C. Basketball Program
 - 1. 5-on-5 League - \$290/team

- D. Athletic Facility Permit
 - 1. Administrative Fee (per each permit) - \$10

- E. Grass Soccer Fields
 - 1. Individual Rate- \$10/hour
 - 2. Organizational Rate - \$1/hour

- F. Softball Fields
 - 1. Individual Rate - \$10/hour
 - 2. *Organizational Rate for all fields - \$1/hour
 - 3. Maintenance Charge per field - \$25/day

*This fee is available to youth organizations deemed by the City to be eligible for season long reservations.

- G. Special Request Cosponsored Commercial Programs
 - 1. Minimum fee - \$25/program
 - 2. Percentage of gross revenue if greater than \$25 - 10% per program
 - 3. Deposit (refundable if facility is not damaged and appropriate revenue received by City) - \$100/program

- H. Fitness Services/Member Prices
 - 1. Personal Training, four (4) sessions - \$140
 - 2. Additional sessions after first four (4) sessions - \$30/session
 - 3. One time / one-hour session - \$50
 - 4. Bring-A-Partner Personal Training, four (4) sessions - \$200
 - 5. Equipment Orientations - \$10
 - 6. Fitness Assessment - \$40

Prices for Group Exercise Classes:

- One (1) month, unlimited classes - \$30
- Three (3) months, unlimited classes - \$75
- Six (6) months, unlimited classes - \$125
- One (1) year, unlimited classes - \$225

- Drop-in class price (adult) - \$5
- Drop-in class price (senior) - \$4
- One (1) year, unlimited classes paid monthly - \$252 (\$21)

I. Tennis Lessons and Courts

1. Tennis Lessons – six lessons - \$90
2. Tennis Lessons - four lessons - \$60
2. Individual Rate - \$4/hour
3. Organizational Rate - \$1/hour

J. Fall Festival - Arts and Crafts Booth Vendors

1. 10'x10' Vendor Space - \$85 (current rate)
2. 10'x20' Vendor Space - \$160
3. 10'x10' Deluxe Space (has two selling sides) - \$145
4. 10'x20' Deluxe Space (has two selling sides) - \$235
5. 10'x20' Three-sided Space - \$300

K. Fall Festival - Food Vendors

1. 10'x20' *Food Vendor Space - \$150

*The fee for a Food Vendor Space includes a temporary food license fee of \$10. Vendor use of electricity is \$15 extra.

THIS Resolution shall take effect and be in force from and after January 9, 2012.

Resolution No. 3843 is hereby rescinded.
